What you need to know.

- Small cell antennas (4G, soon to be 5G) can be installed anywhere without council permission or approval.
- Only adjoining properties need to be notified of the installation.
- There is no legal minimum distance an antenna should be installed from homes, schools, hospitals etc.
- EME Reports are calculated by software simulation and not actually measured.
- Our Protection Standard is based on guidelines established in 1998. It is 1000 times higher than many other countries and doesn't account for non-thermal biological effects, which occur at very low levels and are far more hazardous to children.

Why are we risking it?

- Large scale scientific studies have shown evidence of increased numbers of cancer cases for people living less than 500m from the antenna base stations.^{(1),(2)}
- The latest studies on cell phone use and brain cancer risks, indicate that RF microwave radiation is proven carcinogenic to humans and should now be classified as a "Group 1 carcinogen" along with tobacco smoke and asbestos.⁽³⁾
- Children absorb more microwave radiation than adults.⁽⁴⁾

Thousands of peer-reviewed scientific studies demonstrate harm to human health from RF radiofrequency / microwave radiation.⁽⁵⁾
